The Golf & Country Club Basel ("G&CCB") was founded in 1926. Since 1968 the G&CCB course is located on the "Geissberg", between Wentzwiller and Hagenthal-le-Bas. The golf course can be reached in 15-20 minutes by car from the city of Basel. Although located in Alsace, the G&CCB is a Swiss golf club and is a member of Swiss Golf Association

G&CCB is a private "members club" available to the members and their guests. The facility incorporates a challenging 18-hole golf course, a practice area, a clubhouse, a caddy building and maintenance facilities.

Admission policy of the G&CCB

The Golf & Country Club Basel is a private "Members-Club" with a limited number of members. Prospective members are active golfers or express a strong interest in the sport. They should be intent on participating in the sport and integrating in the social fabric of the Club.

The admission process has 5 steps: A club member (sponsor) who has been an A or B member for at least 5 years proposes an individual or couple for admission. The membership committee reviews the application, interviews the candidates and submits a recommendation to the board. The Board of Directors makes the final decision on admission.

The G&CCB has the following membership categories:

Active A: from the calendar year of the 32nd birthday.

Active B: from calendar year of the 27th up to and including the 31st birthday

Active C: from calendar year of the 19th up to and including the 26th birthday

Juniors: from the calendar year of the 6th to the calendar year of the 18th birthday.

Foreign Members: have the right to use the Club facilities (golf course, driving range, putting greens) six days per year.

Passive members: may reactivate their membership by paying the full annual fee of an A member.

2. Admission fees for the member categories

In the calendar year of the members 32nd birthday, a mandatory transfer from category B to category A takes effect. The admission fee to category A is then due. This can be paid in a single payment or in 5 installments of € 5'500 each or in 10 installments of € 3'000 each.
